UMANG provides single point access to 1,000+ services of Centre and 28 State Governments through Mobile.

During the pandemic, the app helped the school students with reference digital resources (books/audio/video) and many relevant Government services with just few clicks on mobile app., thus bringing efficiency and ease of life.
