Subject:- Grant of recognition to the school from classes Ist to VIII (Without grant-in-aid) w.e.f. academic session 1989-90.

Sir,

With reference to your application on the subject noted above, I am directed to grant recognition to your school as a Middle school (Classes I to VIII) without aid w.e.f. 1989-90 session subject to the fulfilment of the following terms and conditions:-

1. That the school shall abide by the provision of Delhi School Education Act and Rules, 1973 as well as other instructions of the Department issued from time to time.
2. That the school shall admit students without any discrimination of caste and creed as per the norms of the Department.
3. That the school shall appoint fully qualified and eligible staff as per norms of the Department.
4. That the school shall equip the Science Lab. as per the norms of the Department and suitable facilities for practical work shall be provided to the students. More material worth Rs.6000/- may be purchased during 1989-90 and a list of purchased material may be submitted for verification.
5. That the school building shall be completed within a period of two years ending 190-91 and completion Certificate may be submitted for verification.
6. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. Books as per the ratio of ten books per student may be added and facilities of Reading Room may also be provided immediately and more books worth Rs.6000/- be purchased and the list of purchased books may be submitted for verification.
7. Adequate sports material shall be purchased and made available to the students. A sum of Rs. 5000/- may be spent for the purchase of sports material.
8. That the school shall strictly abide by the provision of Delhi School Education Act and Rules, 1973 and payment of pay and allowances and other facilities may be made available as per Section 10(1) of Delhi School Education Act, 1973 to all employees.
9. That the enrolment in one class/section should not exceed 40-45 students or calculated @ 12 sq.ft per student.

10. That the school shall dispense with the services of unqualified and overaged staff, if any, immediately.
11. That Govt. Nominee in the Managing Committee will be asked immediately and all decisions will be taken as mentioned in approved Managing Committee as in the approved Scheme of Management by DDE(AWT).
12. That the Managing Committee of the school shall not increase the fee during the ensuing academic session without the prior approval of the Director of Education which a mandatory requirement under sub-section (3) of Section 17 of D.S.E.R, 1973.
13. That the service contract between the Management and the employees shall be executed immediately.
14. That all facilities as required under Rule 50 and 51 of Delhi School Education Rules, 1973 be made available to the students. Provision of Rules, 6, 7 & 8 be strictly observed.
15. Fresh Health certificate may be obtained from the MCO and may be submitted to this office.
16. The payment of salary to all the employees may be made through crossed cheques.
17. That a reserve fund of Rs. 5000/- in the joint name of the Manager and DDE(Distt. South) may be created within one month from the issue of this letter.
18. That no unrecognised class shall be run in the school premises. Nursery classes may not run in the school building.
19. That the school shall appoint all members of the staff as per post-fixation norms of the Department.
20. Violation of any instructions/provision/conditions/rules & regulations of the Department shall lead to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education, Delhi.
21. That a report about the fulfilment of the above conditions giving the extent to which each condition is fulfilled shall be sent to the undersigned within six months.
